SPEAKING ORDER

Where as, this Directorate have issued promotion order Vide No. NS/ 25/ EMP/ Pt-I/2000/2002 dated, 11/04/2018 , NS/ 25/ EMP/ Pt-I/2000/2629 Dt.26-04-2018 & NS/ 25/ EMP/ Pt-I/2000/3623 Dtd.02-06-2018 for promotion to 71 nos. of incumbent from Ward Incharge to Assistant Matron/ Assistant Nursing Supdt./ Deputy Nursing Supdt., and posted under the disposal of various Joint Director of Health Services of the District and in Medical Colleges on the recommendation of promotion committee meeting held on 11/12/2017.

Where as, All Assam Graduate Nurses Association have challenged the promotion order Vide No. NS/ 25/ EMP/ Pt-II/2000/2002 dated, 11/04/2018 in the Hon'ble Gauhati High Court, Vide Case No. WP(C)/3069/2018, stating that the Assam Nursing Service Rules, 1991 have been totally overlooked and the promotion to the post of Assistant Matron/ Assistant Nursing Supdt./ Deputy Nursing Supdt. was undertaken on the basis of two Gradation lists, which was set aside in the order passed by the honourable High Court in case NO.WP(c)/3069/2018,dt.16/11/2020.

Where as, same kind of subsequesnt order issued Vide No. NS/25/EMP/Part-I/ 2000/ 3623 dated, 02/06/2018 and NO. NS/ 25/ EMP/Pt-I/ 2000/2629 dated, 26/04/2018 of promotion to the post of Assistant Matron/ Assistant Nursing Supdt./ Deputy Nursing Supdt. which was of same nature of promotion made as Vide No. NS/ 25/ EMP/ Pt-I/2000/2002 dated, 11/04/2018,is also revoked herewith.

Where as, now as per the direction of Hon'ble Gauhati High Court in the order passed on Case No. WP(C)/3069/2018 dated 16/11/2020 and Case No. I.A. (Civil)/ 1600/2021 in W.P.(C)/2940/2021, the undersigned hereby revoke the promotion order to the post of Assistant Matron/ Assistant Nursing Supdt./Deputy Nursing Supdt. Vide No. NS/ 25/ EMP/ Pt-I/2000/2002 dated 11/04/2018 , NS/ 25/ EMP/ Pt-I/2000/2629 Dt.26-04-2018 & NS/ 25/ EMP/ Pt-I/2000/3623 Dtd.02-06-2018. A fresh promotion order will be issued within a short period of time using common gradation list published on 23rd April/2021. No any financial recovery will be made from the incumbent who have been working in the higher post on effecting the said promotional order, and the same direction would also be applicable to those incumbents who have retired on Superannuation in the meantime, as per hon'ble Gauhati High Court order vide No. WP(C)/3069/2018 dated 16/11/2020.
