**SPEAKING ORDER**

Whereas, different Advertisements were made by Directorate of Medical Education, Assam, Director of Health Services, Assam, Director of Health Services (FW), Assam and Director, AYUSH, Assam for recruitment of different Grade-III and Grade-IV posts vide advertisements No. Janasanyog/D/10860/21 Dated 7th December, 2021, No. Janasanyog/D/10955/21, Dated: 7th December, 2021, No. Janasanyog/D/ 11153/21, Dated 10th December, 2021, No. Janasanyog /DF/1947/21, Dated 9th December, 2021 & vide No. Janasanyog/DF/1943/21, Dated 9th December, 2021 and Addendum Advertisement vide No. Janasanyog/D/15121/ 21 Dated 8th February, 2022 and Corrigendum Notice vide No. Janasanyog /D/ 16307/21 Dated 26th February, 2022.

Whereas, combined Written Examinations were held on- Grade-III (Technical) on 29/05/2022, Grade-III(Non-Technical) on 12/02/2023 and Grade-IV on 22/01/2023 for recruitment of posts under all four Directorate of Govt. of Assam.

Whereas, candidates were shortlisted in the ratio of 1:2 for Grade-III and 1:1 for Grade-IV posts and called for skill test/aptitude test and document verification.

Whereas, candidates were provisionally selected for appointment on the basis of marks obtained in Combined Written Examination, Skill Test/Aptitude Test and Experience works as well as preliminary document verification. The result of the candidate declared to be successful are provisional and subject to fulfillment of the eligibility criteria as prescribed in the advertisements and veracity of documents.

Whereas, few candidates who were kept withheld for want of proper documents were called for re-verification of documents by a Scrutiny Committee constituted for this purpose Vide Notice No. DME/119/2021/Pt-II/9332 Dated 26/05/2023 on 06/06/2023 at GMCH Auditorium.

Whereas, candidates who were provisionally selected for appointment were issued Appointment Letters by the respective Directorates, few of which could not join their place of posting due to detection of ineligibility to the posts for which they were selected as per advertisement.

Whereas, these candidates who could not join along with other withheld candidates were re-verified by the Scrutiny Committee mentioned above and the Scrutiny Committee submitted its report to the Recruitment Committee.

Whereas, the undersigned gave a patient hearing to Deepshikha Kalita on the matter of appointment in the Office Chamber for several times during office hour.

Whereas, it is to be mentioned that, Deepshikha Kalita was provisionally selected for the post of Driver vide Order No. HSE/Apptt./Driver/96/2023/2 dated 25<sup>th</sup> May'2023 and subsequently she was posted under the disposal of Jt. DHS, Sonitpur. The Joint DHS of All Districts were directed to verify all original relevant documents in respect of the new appointees of Grade-III and Grade-IV appointed and posted in different health institutions under their establishment Vide Letter No. HSE/Apptt/68/Pt-II/2022/4073 Dated 31/05/2023.

Whereas, on subsequent verification of original documents / testimonials as well as requisite eligibility criteria as per advertisement in respect of Deepshikha Kalita by the office of the Joint DHS Lakhimpur, he failed to produce the original driving licence (LMV) in support of her appointment order as Driver.

Whereas, the Joint DHS Sonitpur vide letter No. JDHS/S/2023-24/2909 Dated 02/06/2023 informed the Directorate that the documents submitted by Deepshikha Kalita was verified and found that her Driving Licence is MCWG (Motorcycle with Gear) not for Light Motor Vehicle (LMV). So, she does not satisfy the criteria for the post of Driver.

Whereas, there were candidates with similar situations, who were either issued Appointment Letters or provisionally selected but were not issued Appointment Letters and they could not join due to detection of their ineligibility as per Advertisements to the posts for which they were selected at different levels of scrutiny process.

Whereas, a meeting of Recruitment Committee was convened on 21/08/2023 at 3 PM which was attended by all members of Recruitment Committee. The Committee in the meeting resolved that the candidates, who were provisionally issued Appointment Order by the Directorate of Health Services, Assam, vide Order No. HSE/Apptt./Driver/96/2023/2 dated 25<sup>th</sup> May'2023 and were found to be not eligible as per advertisement for the posts for which they were selected, are to be cancelled.

Whereas, another Scrutiny Committee was constituted by the Director of Health Services, Assam for the purpose of re-verification of the original documents and Deepshikha Kalita who was provisionally appointed and posted for the post of Driver under the disposal of the Joint Director of Health Services, Sonitpur was called for re-verification of original documents on 27/09/2023 at 1:00 PM at the Conference Hall of the Directorate of Health Services, Assam vide notice no. HSE/233/2023/7681 dated 22/09/2023.

Whereas, The Scrutiny Officer and all the member of Scrutiny Committee was assembled at above mentioned venue and time, where Deepshikha Kalita was also attended. After re-verification of all the relevant original documents, the Scrutiny Committee resolved that Deepshikha Kalita who was provisionally appointed by the Directorate of Health Services, Assam, vide Order No. HSE/Apptt./Driver/96/2023/2 dated 25<sup>th</sup> May'2023 and was found to be not eligible as per advertisement for the posts for which she was selected, are to be cancelled.

Under the backdrop of the resolution taken by the Recruitment Committee on 21/08/2023 and the Scrutiny Committee on 27/09/2023, the following candidate who was appointed under Directorate of Health Services, Assam are hereby cancelled.
