**SPEAKING ORDER.**

Whereas, Mrs Pranati Choudhury, Staff Nurse at Kanaklata Civil Hospital, Tezpur have submitted a prayer petition on 10<sup>th</sup> May/2022 to the undersigned in connection with awarding promotion to the post of Ward-In-Charge/Ward Sister/ Nursing Sister/Diet Sister/OT sister.

Whereas, as per the document produced by Mrs Pranati Choudhury, Staff Nurse at Kanaklata Civil Hospital, Tezpur, is eligible to be promoted to Ward-In-Charge/Ward Sister /Nursing Sister/Diet Sister/OT sister as per SC category and seniority. But her caste was wrongly reflected as General Category instead of SC category in the final common gradation list published on 2<sup>nd</sup> April/2022 vide this Directorate letter No. NS/SN/84/Promotion/Pt-II/2016/365 in the DHS website, for which she was not considered for promotion in the order published on 5<sup>th</sup> May/2022 vide this Directorate order No. NS/SN/84/Promotion/Pt-III/2016/454.

Whereas, this Directorate published a provisional common gradation list of Staff Nurse on 11<sup>th</sup> January/2022 vide this Directorate order No. NS/SN/84/Promotion/Pt-II/2016/113 and give opportunity to the incumbent for a period of 7(seven) days to meet up any objection, claims on seniority or any factual error/omission. Accordingly after receiving objection from the incumbent, this Directorate have published the final common gradation list of Staff Nurse on 2<sup>nd</sup> April/2022 vide this Directorate order No. NS/SN/84/Promotion/Pt-II/2016/365.

Whereas, due to non receipt of caste certificate in respect of Mrs Pranati Choudhury, Staff Nurse in due course of time, this Directorate could not consider her name for promotion. Now after receipt of prayer petition along with caste certificate, it has been corrected in the final common gradation list and found her eligible for promotion to the next higher post of Ward-In-Charge/Ward Sister /Nursing Sister/OT Sister/Diet Sister as per seniority

Hence, she may be promoted to the next higher post of Ward-In-Charge/Ward Sister./Nursing Sister/OT sister/Diet Sister.
