ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur the 23<sup>rd</sup> May, 2016

No.HLA.342/2010/Pt./88: In the interest of public service and pursuant to Cabinet approval accorded on the 28<sup>th</sup> of February, 2016, the Governor of Assam is pleased to notify the setting up of "THE ASSAM GOVERNMENT HEALTH SCHEME SOCIETY" hereinafter referred as "THE AGHS SOCIETY" for formulating and administering "the Assam Government Health Scheme".

The aforesaid Scheme envisages Cashless Medical Treatment facilities including diagnostic tests and essential medicines for State Government employees and their eligible family members, State Government pensioners including their spouses, State Government family pensioners, All India Service (AIS) officers and their eligible family members, pensioners of AIS and their spouses, AIS family pensioners and reemployed AIS officers and spouses. The Government of Assam may from time to time extend the AGHS to employees and eligible family members of any organization or to any other person(s).

The AGHS Society shall be formed in accordance with the provisions of the Memorandum of Association (MOA) and the Rules and Regulations (Bye laws) framed for this purpose and shall be registered under the Societies Registration Act, 1860 (Act No. XXI of 1860). The Society will be constituted with a Governing Body to be headed by the Hon'ble Chief Minister, Assam and it shall be the Apex Body of the Society and shall exercise all such powers in connection with the affairs of the Society within the purview of the MOA and Rules and Regulations of the Society. There shall also be an Executive Committee of the AGHS Society headed by the Chief Secretary, Assam with such other members and a Chief Executive Officer for managing the day to day affairs of the Society which will function under the overall control and superintendence of the Governing Body and shall exercise all powers as may be delegated by the Governing Body.

Shri Mukut Phukan, ACS, Deputy Secretary to Government of Assam, Health & Family Welfare Department shall take necessary steps for registration of "THE ASSAM GOVERNMENT HEALTH SCHEME SOCIETY" under the Societies Registration Act, 1860 (Act No. XXI of 1860) within a period of 15 days from the date of issue of this Notification and shall take all subsequent required approvals, including, inter-alia, framing of the guidelines, Rules and Regulation for the Assam Government Health Scheme Society.


