NOTICE

Whereas, in the Rule12 of the Assam Medical Colleges (Regulation of Admission of Post Graduate Course) Rules 2006 amended upto 2012 it is stated as under :-

“12. AGREEMENT. – After being selected the candidates admitted under State Quota seat including candidates of Teachers Quotas and State Health Service Quota shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs.100/- (Rupees one hundred) only in the format as appended in Appendix-II.

The Students who take admission in Post Graduate Course under All India Quota in the Medical Colleges of Assam and are desirous to receive stipend awarded by the Government of Assam shall have to enter into an agreement as executed by the State Quota Candidate (as in Appendix II) binding himself/herself to serve under the Government of Assam for a period of 10 years on completion of Post Graduate Course and in breach thereof to pay a sum of Rs.20.00 lakhs only to the Government as compensation and deliver the same to the Government. However, if any student from All India Quota does not want to receive the stipend, he/she shall be exempted from the purview of this agreement.”

In the light of above, post graduate doctors who have passed out in the year 2019 from Medical Colleges of Assam were selected for engagement on contractual basis for Specialist 1 year compulsory post P.G. under the Directorate of Medical Education, Assam vide order No.DME/157/Post PG/2019/10135, Dtd. 16/07/2019 and NHM vide order No.NHM-31013 (11)/42/2018-HRD-NHM/3817, Dtd.12/07/2019 & No.NHM-31013(11)/42/2018-HRD-NHM/3853, Dtd.12/07/2019.

Now, it has been observed that the following selected post P.G. Doctors have not Joined/Reported to their allotted place of posting, which is considered as violation of the agreement Conditions. Therefore, the said Candidates are directed to attend their allotted assignment in respective Institution/College/Hospital immediately within 15(Fifteen) days from the date of publication of this notification, failing which, necessary legal action shall be initiated against them as per provision of the agreement Conditions.


